



## **DEFINITIVE MAP REVIEW OF PUBLIC RIGHTS OF WAY PARISH OF COMBE MARTIN Consultation Schedule**

The Wildlife and Countryside Act 1981 requires the County Council to keep the Definitive Map of public rights of way under continuous review and to make modifications where it appears that routes should be added, regraded or deleted. A review is currently being undertaken in the **Parish of Combe Martin**.

**25 suggestions for changes to rights of way network have come from the Parish Council and members of the public. These are listed below:**

- Proposal 1: Dedication of a small spur of footpath from car park to beach.**
- Proposal 2: Dedication of a footpath across Cobblers Park.**
- Proposal 3: Dedication of a footpath from No. 33 to West Challacombe then to coast path**
- Proposal 4: Dedication of a footpath on missing link of coast path.**
- Proposal 5: Deletion of stub of FP 32 north of coast path.**
- Proposal 6: Upgrading FP No. 23 to a bridleway.**
- Proposal 7: Dedication of a footpath around edge of Holland's Park.**
- Proposal 8: Upgrading Footpath No. 13 (Rock Lane) to a bridleway.**
- Proposal 9: Upgrading Footpath No. 16 (Pentis Lane & Watery Lane) to a bridleway.**
- Proposal 10: Upgrading Footpath No. 17 (Chapel Lane) to a bridleway.**
- Proposal 11: Upgrading Footpath No. 17 (Corner Lane) to a bridleway.**
- Proposal 12: Upgrading Footpath No. 18 (Badgaver Lane) to a bridleway.**
- Proposal 13: Add Usticke Lane and Comers Lane as a Bridleway.**
- Proposal 14: Upgrade Footpath No. 20 and part Footpath 31 to bridleway (Knapdown Lane & part Girt Lane)**
- Proposal 15: Add Part of Lower Dean Lane and the link to Skirhead as a footpath.**
- Proposal 16: Add footpath along Genesis Lane to Holland's park.**
- Proposal 17: Add bridleway along Kiln or Pig lane.**
- Proposal 18: Add footpath along Rocky Lane.**
- Proposal 19: Add footpath Bowling Green Lane along Blackmore Ham to High St.**
- Proposal 20: Add footpath to Water Lane.**
- Proposal 21: Divert Footpath No. 21 to walked line,**
- Proposal 22: Add footpath from corner FP No. 2 on the used path to Woodlands Rd.**
- Proposal 23: Correct line of Footpath No. 8 to go to Newberry Beach.**
- Proposal 24: Add the slipway to Combe Martin Beach as a restricted byway.**
- Proposal 25: Add a footpath along Rew's Close and part Rosea Bridge Lane.**
